Acknowledgements

I affirm that I am financially capable of maintaining my enrollment for my children for the 2009-10 school year based on the tuition and fees detailed above. I understand I am contracting for a year of services for my child with Real Life Christian Academy.

I understand that prior to the first day of class for the 2009-10 school year I must pay all fees and tuition according to the payment schedule. Failing to meet these payment deadlines will result in late fees and might result in my child being dropped from the class roll. It is my responsibility to know these deadlines. I also understand that in order to re-enroll my child I will have to pay all delinquent charges and repay the registration fee; re-enrollment is contingent on available classroom space.

I understand that I may pay tuition and fees in full by June 1, 2009 and receive a 2% discount on tuition. I also understand that if I do not make payment in full I must enroll in the FACTS payment plan. Once school begins, if I inactivate or suspend the payment plan, all charges for the school year become immediately due and payable.

I understand that withdrawing my child midterm brings financial hardship on the school; if I withdraw my child during the school year, I will owe a withdrawal fee equal to 10% of the total tuition charges for the year to help offset the loss to the school. In the case of expulsion, all tuition and fees become immediately due and payable.

I understand that application fees, enrollment fees, materials fees and registration fees are non-refundable and non-transferable.

I understand that if my account is more than 30 days past due my child may not be permitted to attend class. If my account is more than 60 days past due my child may be administratively withdrawn for the school year, and I will owe all accrued tuition and fees plus the 10% withdrawal fee. RLCA will not release my child's records until all tuition, fees and charges have been paid in full.

By signing this form I acknowledge that I have read and understand the terms of this contract and I agree to the terms and conditions herein. My signature below also indicates that I am solely responsible for the tuition and fees and I agree to make payments in a timely fashion.
